

## <u>Transboundary cooperation for a resilient Horn of Africa</u>

Land degradation in the Horn of Africa affects the livelihoods of millions of people and exacerbates food insecurity. To address the issue, UNCCD's Peace Forest Initiative organized a workshop to focus on sustainable land management, promote resilience through regional cooperation and align efforts with initiatives like the Great Green Wall.

## RESILAND CA: Flagship of Peace Forest Initiative tackles land degradation in Central Asia

Central Asia faces severe land degradation, which impacts a country's productivity, livelihoods and climate resilience. In response, RESILAND program is designed to restore degraded landscapes, boost ecosystem resilience and support livelihoods in vulnerable border areas across four countries.





## <u>Laying the ground to restore our</u> <u>future cities</u>

The second "Trigger Change!" university course on Urban Land Restoration was launched on 16 July 2024. The course is about innovative solutions for sustainable urban land management, and is targeted for use in at least 1,000 universities worldwide.

#### <u>Aridity threshold of ecological restoration mitigated atmospheric</u> <u>drought via land-atmosphere coupling in drylands</u>

This study explores how restoring ecosystems in drylands affects the relationship between land and atmosphere, which impacts drought conditions. Using a structural equation model, researchers identified two key pathways, namely soil moisture and vegetation. The researchers found that soil moisture influences drought more than vegetation does -- by twice as much. The study examines how restoration efforts in specific regions can help reduce ecosystem vulnerability to drought, especially in areas with moderate aridity.

#### The State of the World's Mangroves 2024

The *State of the World's Mangroves 2024* report provides an extensive overview of global mangrove ecosystems. It highlights their critical role in climate resilience, biodiversity and coastal protection. It shares new insights and metrics using better imaging tools of mangroves as well as insightful case studies offering perspectives for the future. It also details methods and guidelines for the conservation and restoration of mangroves.

#### South-South Cooperation for Sustainable Land Management and Ecosystem Restoration

South-South Cooperation's (SSC) importance for accelerating knowledge exchange in sustainable land management and ecosystem restoration is discussed in a brief published by The Food and Agriculture Organization of the United Nations (FAO). The brief is based on a survey of three regions in the global South, and highlights the immense potential for SSC to scale innovative solutions for food security, sustainable land use and livelihoods.




